• 50 Hrs. X-Country; 40 Hrs. actual or simulated instrument time; 35 Hrs of Instrument Training.

Theory: Estimated is 5 days of Theory training + 3 - 5 Weeks Self study

IACRA: <u>https://iacra.faa.gov/iacra/</u> Before the Practical Exam you need to register yourself at IACRA website in order to fill in your Exam Application. You need to bring The Log On Codes for your account on the day of the Practical Exam!

EASA Conversion competency based: Since the BASA agreement between the FAA and EASA is slowly implemented new options are possible. Based on your FAA Instrument rating you can convert it into an Competency Based EASA Instrument Rating if you meet the following requirements:

• 50 hours as Pilot in Command under IMC/IFR (to be proved by flight plans)

NiftrikAir will prepare you then for A Practical Exam by;

- 6-12 Hours exam flight training
- 1-3 days Oral exam preparation
